**ADDENDUM No. 4:  
TOWN OF MEDLEY BID No. 2011-07**

**PAVING AND DRAINAGE IMPROVEMENTS FLOOD MITIGATION AREA  
JANUARY 27, 2012**

This Addendum forms a part of the Bidding Documents and will be incorporated into the Contract Documents. Insofar as the Invitation for Bid or Drawings or both are inconsistent, this Addendum governs. The Invitation for Bid (IFB) is revised to the extent specifically amended by this Addendum. Otherwise, all provisions of the IFB remain in effect.

The addendum will hereby modify, correct, and/or supplement the contract documents as follows:

4-1: SCHEDULE OF EVENTS: Event number 3 – Opening of Bids.

- **Change date to February 6<sup>th</sup>, 2012.**
  - Bids are due by 3:00 pm. Bid opening at 3:01 pm.
  - The last day for Bidding Contractors to submit questions will be at 5:00 pm on February 1<sup>st</sup>, 2012.
  - Responses will be made available on February 2<sup>nd</sup>, 2012.

4-2: INVITATION TO BID: Section 1-32: Summary of Documents to be submitted by Bidders:

- **Remove** the existing Bid Table and **add** the revised Bid table (See Attachment 4-1)
- Below is an itemized list of all the changes to date of the Bid Table:
  - New Item (Item 3): Pavement Demolition.
  - New Item (Item 4): Curb and Gutter Demolition.
  - Revised Quantity (Item 6): New Limerock Base in 3" lifts (6" total).
  - Revised Quantity (Item 9): New 2" Type SP-9.5 Asphalt Structural Course.
  - Revised Quantity (Item 10): New 1.5" Type SP-9.5 Asphalt Wearing Course.
  - Revised Quantity (Item 14): Welded Wire Fabric Reinforcement.
  - Revised Quantity (Item 21): Concrete Apron Around Swale Catch Basins.
  - New Item (Item 26): 1" Type SP-9.5 Asphalt Structural Course - for resurfacing along NW 95th Avenue.
  - New Item (Item 27): Removal of Existing Drainage Structures.
  - New Item (Item 28): Removal of Existing Drainage Pipe.
  - New Item (Item 29): Abandonment of Existing Drainage Pipe.
  - Revised Quantity (Item 31): Swale Inlet Type P-10 (42" Dia.) (Max. 15' Deep).
  - Revised Quantity (Item 32): Swale Inlet/Manhole Type J-10 (Any dimension) (Max. 15' Deep).
  - Revised Quantity (Item 35): Manhole Type P-7T (Any dimension) (Max. 15' Deep).

- New Item (Item 36): Existing Inlet/Manhole Modification.
- Revised Quantity (Item 42): Exfiltration Trench (24" Diameter Perforated Pipe).
- Removed Item (formally Item 42): Disposal of clean material and transportation.
- Removed Item (formally Item 43): Proctor Test, Field Density Test, LBR, Sieve Analysis, Organic Content.

4-2: OFF-DUTY POLICE OFFICE RATE: The rate of an off-duty Town of Medley police officer is

4-4: **CONSTRUCTION DOCUMENTS**: A complete set of revised construction plans are being provided as part of Addendum #4. Bidding contractor shall base all their unit items according to this REVISED SET OF COMPLETE CONSTRUCTION DOCUMENTS.
