NOTICE IS HEREBY GIVEN that a special meeting of the Town Council of the Town of Medley shall be held on Monday, June 5, 2017 at 5:15 p.m. at the Medley Municipal Services Facility Council Chambers at 7777 NW 72nd Avenue, Medley, Florida 33166, at which time and place the Town Council shall consider the following:

- Appeal of Termination by Former Town Employee

Any and all interested parties are invited to attend this meeting. Any party who decides to appeal any decision made by any board, agency, council, or commission with respect to any matter considered at such meeting or hearing will need a record of the proceedings, and for that reason, may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

NOTE: If you are not able to communicate, or are not comfortable expressing yourself in the English language, it is your responsibility to bring with you an English-speaking interpreter when conducting business at the Town of Medley during your appearance at a hearing. This person may be a friend, relative or someone else. A minor cannot serve as a valid interpreter. The Town of Medley **DOES NOT** provide translation during any public hearing or during any quasi-judicial proceeding.
