



NOTICE OF SPECIAL MEETING TOWN OF MEDLEY, FLORIDA

NOTICE IS HEREBY GIVEN that a special meeting of the Town Council of the Town of Medley shall be held on Monday, October 16, 2017 at 5:15 p.m. at the Medley Municipal Services Facility Council Chambers at 7777 NW 72nd Avenue, Medley, Florida 33166, at which time and place the Town Council shall consider the following:

- Discussion and Action regarding Business Insurance Policy Renewal effective November 1, 2017;
- Resolution Approving the Town of Medley State Legislative Priorities for 2018.

Any and all interested parties are invited to attend this meeting. Any party who decides to appeal any decision made by any board, agency, council, or commission with respect to any matter considered at such meeting or hearing will need a record of the proceedings, and for that reason, may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
